## **1. Introduction**

Welcome! You have arrived at a website operated by Aver Inc. d/b/a Enlace Health or our affiliates (“**Enlace Health**,” “**we**,” “**our**” or “**us**”). Enlace Health delivers the only end-to-end solution that solves the infrastructure challenges driving today’s unsustainable healthcare system. Connecting payers, providers, and patients, Enlace™ empowers any type of healthcare delivery model, from facilitating retrospective programs to enabling risk for prospective programs. At Enlace Health, we take your privacy very seriously. This Privacy Notice (“**Notice**”) describes the types of personal information (as defined below) that we collect, how we use it, how and when we share it, and the rights you have with respect to your information. It also explains how we communicate with you and how you can make inquiries and requests to us about your information. We strive to help you understand how we use your information to improve our products, services, marketing, and interactions with you, as part of our commitment to maintaining your trust.

## **2. Scope**

This Notice applies when you use or access the publicly available website, [www.enlacehealth.com](http://www.enlacehealth.com) (the “**Site**”); or otherwise provide Personal Information or interact with us online or in-person. We do not collect Protected Health Information (“**PHI**”), as defined by the Health Insurance Portability and Accountability Act of 1996 and its implementing guidance and regulations (“**HIPAA**”), on this Site. **For individuals using our Solutions, please see our [Products Privacy Notice](#).** For the purpose of this Notice, “**Personal Information**” means any personal information relating to an identified or identifiable individual that is protected by applicable privacy laws. We refer to all of the above as “**Services**.” By using the Services, you agree to our [Terms and Conditions](#).

Where applicable, we indicate whether and why you must provide us with your Personal Information, as well as the consequences of failing to do so. If you do not provide Personal Information when requested, you may not be able to benefit from our Services if that Personal Information is necessary to provide you with the Services or if we are legally required to collect it.

### 3. What Information We Collect

This section describes what information we collect from you through our Site or Services. We may receive information (including Personal Information) in the following ways:

#### Information That You Provide to Us

As you interact with our Site or Services, we may collect Personal Information via webforms or inputs/uploads on our Site, as well as through webinars, tradeshow, telephone calls, emails and other communications with you. Specifically, we collect the following Personal Information:

- **Contact information.** We may collect information such as your first and last name, email address, company name, business address, telephone numbers and mobile numbers;
- **Social media information.** We may collect information such as social media handles, content and other data shared with us through third-party features that you use on our Site or Services or on our social media pages such as Facebook, Twitter, LinkedIn and YouTube;
- **Employment information.** If you apply for employment with us, we may collect information such as your current or past employment or educational information, as well as references and referrals provided to us in connection with your employment applications; and/or
- **Other information.** We may collect other information that could reasonably be used to identify you personally.

Your decision to provide us with Personal Information is voluntary, but if you choose not to provide any requested information, you may not be able to take advantage of all the features of the Site or Services.

#### Information That Is Automatically Collected

Like many businesses, we and/or our service providers may automatically collect and/or store certain information when you visit or interact with the Site or Services ("**Usage Information**"). This Usage Information may be stored and/or accessed from your personal computer, laptop, tablet, mobile phone, cable box, smart TV or other device (a "**Device**") whenever you visit or interact with our Site. Usage Information may include:

- Your IP address, IDFA, Android/Google Advertising ID, IMEI, cable box ID number or another unique identifier;
- Your Device functionality (including browser, browser language, settings and behavior, operating system, hardware, mobile network information);
- Referring and exit web pages and URLs;
- The areas within the Site that you visit and your activities there, including remembering you and your preferences;
- Your Device location or other location information, including the zip code, state or country from which you accessed the Services;

- Your Device characteristics;
  - Certain other Device data, including the time of day you visit our Site or other information used to provide analytics or other usage information;
  - Information about your engagement with our emails; and
- Statistical information about how both unregistered and registered users, collectively, use the Site and Services. This aggregate information is derived from Personal Information but cannot be tied back to you or your web browser.

### **Information Collected from Third Parties**

The Site may include functionality that allows certain kinds of interactions between the Site and your account on a third-party website or application. The use of this functionality may involve the third-party site providing information to us. For example, we might obtain information about the traffic and usage of Enlace Health from third parties. These third parties also use cookies and other tracking technologies to capture information about your interactions with Enlace. Enlace Health does not have control over the information that is collected, used, and shared by these third parties. We encourage you to review the privacy statements of these third parties to understand their privacy practices.

We might also receive Personal Information from tradeshow organizers and webinar platforms that we utilize.

## **4. How We Use Your Information**

We use your information for business and commercial purposes, including to use or browse the Site, to offer our Services, to provide you with customer service, to prevent security and fraud, to provide marketing information about our products and services, and to perform website analytics.

We may use the information we collect about you in a variety of ways, including to:

### **To Provide Our Services**

We process certain Personal Information when you access or use our services, including to facilitate the functionality of our Site and customize experiences and personalization when you are on our Site.

### **To Communicate with You**

We may process certain information in order to communicate with you in relation to our Services, our marketing, and your requests, including to:

- communicate with you about our Services and Products such as Episode Snapshot, Episode Advantage and Network Configurator;
- respond to your customer service inquiries and requests for demos or information; and
- market our Products and Services to you via cross-contextual advertising (also known as retargeting) on social media and other platforms.

### **To Improve Our Site and Services**

We want to ensure that our Site and Services are continually expanding so that we meet and exceed your needs and expectations. To do so, we may process certain Personal Information to maintain, improve, and analyze our Site or Services; and detect, prevent, or investigate suspicious activity or fraud.

### **To Comply with Applicable Laws**

We may be required to process certain Personal Information under certain laws and regulations, such as tax laws, as well as to:

- maintain appropriate records for internal administrative purposes; and
- comply with applicable legal and regulatory obligations, and respond to lawful governmental requests, as needed.

### **To Enforce our Terms, Agreements, or Policies**

To maintain a safe, secure, and trusted environment for you when you use our Site and Services, we may use Personal Information to ensure our terms, policies, and agreements with you and any third parties are enforced.

### **Evaluate Your Application for Employment**

We may use Personal Information to evaluate your application for employment.

### **With Your Consent**

We may process certain Personal Information in order to fulfill any other business or commercial purposes at your direction or with your consent.

## **5. Use of Cookies**

We use cookies and other tracking technologies to personalize your experience, analyze user trends, and improve the Services. These tracking technologies allow us to collect information such as your device type, browser type, interactions with our Site, geographic location, your web request, the date and time of your web request, your Internet Protocol address, the domain name of your Internet service provider and other data. If you can be identified from this information, for example by combination with other pieces of information, then we will treat this information as Personal Information.

You can alter the configuration of your browser to refuse to accept cookies, but it is possible that doing so may cause limited functionality of the Site. For example, we may not be able to recognize your computer or device, and you may need to log in every time you visit.

We may use “cookies” (a small text file sent by your computer each time you visit our site) or similar technologies to record log data. Many browsers default to accepting cookies. You may be able to change this setting in your browser and you can also clear your cookies. If you do, you may lose some functionality of our site. Check your browser’s help function to learn more about your cookie setting options.

We may use the following types of cookies:

- **Strictly necessary cookies.** These cookies are essential for you to browse the website and use its features, such as accessing secure areas of the site. Cookies that allow web shops to hold your items in your cart while you are shopping online are an example of strictly necessary cookies. While it is not required to obtain consent for these cookies, what they do and why they are necessary should be explained to the user.
- **Functionality cookies.** Also known as “preference cookies,” these cookies allow a website to remember choices you have made in the past, like what language you prefer, what region you would like weather reports for, or what your user name and password are so you can automatically log in.
- **Analytics cookies.** Also known as “performance cookies,” these cookies collect information about how you use a website, like which pages you visited and which links you clicked on. None of this information can be used to identify you. It is all aggregated and, therefore, anonymized. Their sole purpose is to improve website functions. This includes cookies from third-party analytics services as long as the cookies are for the exclusive use of the owner of the website visited.
- **Advertising cookies.** These cookies track your online activity to help advertisers deliver more relevant advertising or to limit how many times you see an ad. These cookies can share that information with other organizations or advertisers. These are persistent cookies and almost always of third-party provenance.

We might also use pixel tags, which are small graphic files that allow us and third parties to monitor the use of the Site and provide us with information based on your interaction with the Site. These tags may collect the IP address of the device from which you loaded the page and the browser type. Pixel tags are also used by our third parties to collect information when you visit our site, the links and other actions you take on our site, and we may use this information in combination with cookies to display targeted advertisements.

Other data technologies may be used that collect comparable information for security and fraud detection purposes.

## 9. International Transfers of Personal Information

The Site is operated and targeted toward audiences in the United States. If you are located in another jurisdiction, please know that your information will be transferred to, stored, and processed in the United States. By using the Site and providing us with information, you consent to this transfer, processing and storage of your information in the United States. It is important to note that the privacy laws in the United States may not be as comprehensive as those in other countries such as those in the European Union ("EU"). Our service providers use appropriate safeguards to transfer your Personal Information to the United States.

## 10. Security

We seek to use reasonable organizational, technical and administrative measures to protect Personal Information. Unfortunately, no data transmission or storage system can be guaranteed to be 100% secure. Where we have given you (or where you have chosen) a password so that you can access certain areas of our site, you are responsible for keeping this password confidential. If you have reason to

## 11. Data Retention

We will retain your Personal Information only for as long as is necessary for the purposes set out in this Privacy Notice. We will retain and use your Personal Information to the extent necessary to comply with our legal obligations (for example, if we are required to retain your Personal Information to comply with applicable laws), resolve disputes and enforce our legal agreements and policies.

When deciding how long to keep your information, we consider:

- How long we have had a relationship with you or provided our Services to you;
- Whether we are subject to any legal obligations (e.g., any laws that require us to keep transaction records for a certain period of time before we can delete them)
- Whether we have taken any legal positions (e.g., in connection with any statutes of limitation).

In some circumstances we may choose to de-identify your Personal Information (so that it can no longer be associated with you) for research or statistical purposes, in which case we may use this information indefinitely without further notice to you.

## 12. Your California Privacy Rights

This section of our Privacy Notice applies to consumers who reside in California. We adopt this section to comply with the California Consumer Privacy Act (“**CCPA**”) and California Privacy Reform Act (“**CPRA**”).

If you are a California resident, you may be able to exercise the following rights. We will honor requests received to the extent required by applicable law and within the time provided by law.

### Right to Access and Information Regarding Personal Information

You have the right to request that we disclose to you the categories and specific pieces of Personal Information we have collected about you. Specifically, you have the right to request that we disclose the following to you, in each case in the twelve-month period preceding your request:

- The categories of sources from which the Personal Information is collected;
- Our business or commercial purpose for collecting or selling Personal Information;
- The categories of third parties with whom we share Personal Information;
- The specific pieces of Personal Information we have collected about you;
- The categories of Personal Information about you, if any, that we have disclosed for monetary or other valuable consideration and the categories of third parties to which we have disclosed the information, by category or categories of Personal Information for each third party to which we disclosed the Personal Information; and
- The categories of Personal Information about you that we disclosed for a business purpose.

### Right to Correct Personal Information

You have the right to request that we correct any inaccurate information that we maintain about you.

### Right to Deletion of Personal Information

You have the right to request that we delete Personal Information about you that we have collected from you. There may be certain exceptions to our obligation to delete your information such as if you have an existing account or transaction with us or if we have a legitimate business reason to keep your information.

### Right to Opt-Out

You have the right to opt out of the sale of Personal Information. ### Right to Limit Use of Sensitive Personal Information

### Requests to Exercise Your Rights

You or your authorized agent may make a request to access, correct, delete or opt-out of the disclosure of your Personal Information for business purposes. We may limit our response to your exercise of the above rights as permitted by law. We will confirm receipt of the request within 10 business days describing our verification process. We will respond to your request within 45 days or let you know if we need additional time.

### Data Sharing for Direct Marketing Purposes
